The Dordi Rural Municipality, Lamjung invites electronic bids from eligible bidders for the Procurement of Tools and Equipment for Basic and Emergency Health Services under National Competitive Bidding procedures specified in Public Procurement Act and Regulations. - 4. Pre-bid meeting shall be held at the office of Dordi Rural Municipality, Office of the Municipal Executive, Nauthar, Lamjung at 23-05-2024 13:00 hrs.
- 5. Electronic bids must be submitted to the office through PPMO website www.bolpatra.gov.np before 03-06-2024 12:00 hrs. Bids received after this deadline will be rejected. The bids will be opened in the presence of Bidders' representatives who choose to attend at 03-06-2024 13:00 hours at the office of Dordi Rural Municipality, Nauthar-Lamjung, Gandaki Province- Nepal. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of 1,25,000.00NRs which shall be valid for 30 days beyond the validity period of the bid.
- 6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
