Theestimated amount for the works is Rs. 4010704.37 (Forty lakhs ten thousand seven hundred four rupees and thirty seven paisa only including VAT, PS and Contingency)

- 5. Sealed or electronic bids must be submitted to the office of Dordi Rural Municipality, Office of the Municipal Executive, Nauthar, Lamjung through PPMO website www.bolpatra.gov.np/egpon before 17-03-2024 12:00 hours. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 17-03-2024 13:00 at the office of Dordi Rural Municipality. Bids must be valid for a period of 30 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of 1,00,000 (0.1 million) which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
